Introduction

This CAR form is produced following a fire incident in the main waste processing area at A1 Wokingham Car Spares (WML 83313 / EPR FP3390EU) on the 20th of December 2023.

Smoke was seen coming out of the waste in the early hours of the morning and the alarm was raised. The Site Manager and the Fire service arrived on site shortly after the alarm was raised. The burning waste was contained within the bays and the fire was put out by the Fire service. Fire water did not escape the site.

The incident was reported by the Fire Service to the Environment Agency.

Observation

Officer E Bilankulu visited the site on the morning of 20th December 2023 and went round to the area of the incident with the Site Manager. I saw the burnt waste had been moved aside and some of the fire water run off remained in the bay and had not drained through the interceptor. The cause of the fire was not known but was thought to be a Lithium-ion battery possibly left in a scooter. I saw the CCTV footage of the event. The Site Manager confirmed the fire water left in the bay will be tankered off.

Paperwork for the firewater destination was requested and has since been provided by the operator.

It was established that the site followed the Fire Prevention Plan.

Non-Compliance
