The site was visited following reports made to the Environment Agency, that burning of waste had been taking place within the site. It was indicated that this had been happening over a number of weeks but specifically on the previous evening – 28 October 2019.

When we arrived on site we spoke to Chloe Djemal and explained why we were there. Chloe said that a week or two ago the gardener in their nearby residential properties had been burning garden waste in the garden but he had been told to stop.

We looked around the site with Gary Webb, but could find no evidence of any burning having taken place.

No non-compliances have been recorded for this visit. This means that the permit remains in compliance Band B.
